SHRIMALI): (a) The material for the Directorate of Social Welfare and its subordinate organisations was purchased through the Directorate General of Supplies and Disposals sixteen times; it was purchased direct after obtaining 'no objection' certificates from the D'rector General of Supplies and Disposals fifteen times and on no occasion was it purchased direct without obtaining such a certificate.

FFAILURE OF STEEL PRODUCERS TO SUP-PLY COMPONENTS FOR RAILWAY WAGONS ETC.

59. SHRI DAHYABHAI V. PATEL: Will the Minister of STEEL AND HEAVY INDUSTRIES be pleased to state:

(a) whether it is a fact that the steel producers in the country have failed to supply components of railway wagons, locomutives and coaches manufactured in India;

(b) if so, the names of the steel Plants which have failed to do so, and in view of their failure, what other arrangements Government propose to make up the deficiency; and

(c) whether this situation has affected the production of steam engines, and/or diesel engines?

THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM): (a) and (b) Steel plants do not produce components but supply steel sections from which components are made for railway wagons, locomotives and coaches that are manufactured in the country. Presumably, the hon. Member is referring to these steel sections.
