Recruitment to "included posts" is regulated by the Home Ministry on all Secretariat basis.

#### EXPANSION OF ROURKELA STEEL PLANT

362. SHRI M. P. BHARGAVA: Will the Minister of STEEL AND HEAVY INDUSTRIES be pleased to state:

(a) whether any agreement has been reached between India and Germany for the expansion of the Rourkeia Steel Plant; and

(b) if so, what are the terms thereof?

THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM): (a) and (b) Yes, Sir. The West German Government have agreed in principle to the granting of a credit for meeting the foreign exchange cost of the expansion of the Rourkela Steel Plant, after certain action has been taken with a view to bring the existing Plant to full working.
