ed to bring tneir movable and immovable properties to India.

SHRI DINESH SINGH: How can anyone bring immovable property?

THE DEPUTY CHAIRMAN: Immovable property does not move.

SHRI A. B. VAJPAYEE: According to the Agreement, a migrant is allowed to bring movable property with him. But is it not a fact that really they are not allowed to bring any property with them and that many of them have come as paupers to India?

SHRI MEHR CHAND KHANNA: It •would be correct to say that we entered into a movable property agreement between India and Pakistan on the western side and that has been largely implemented. As far as the eastern side is concerned, I have seen people coming from Pakistan to India and whatever little belongings they have of movable property they are bringing with them.

SHRI A. D. MANI: The hon. Deputy Minister stated just n'ow that these migrations are due to their feeling of fear of life and property in Pakistan. If that was so, I would like to know what representations the Government of India have made to Pakistan about this matter.

SHRI JAWAHARLAL NEHRU: I would add to my colleague's answer by saying that this is due to economic conditions. The economic conditions there have not been good, and the pressure of these conditions has made them come. As for the other matters, We have repeatedly pointed out t'o the Pakistan Government about this feeling of insecurity among the minority community there.

## RELIGIOUS INSTRUCTIONS IN GOA SCHOOLS

- •351. SHRI DEOKINANDAN NARAYAN: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that the Goa Administration has banned all reli gious instructions in schools in Goa;
- (b) if s'o, what are the reasons therefor?

THE MINISTER OF STATE' IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): (a) and (b) In accordance with the recommendation made by the Education Committee on Goa and in accordance with the position in other parts of India, the Goa Administration has issued instructions that no religious instruction should be given in Government Schools. The Goa Administration has clarified that this does not mean that moral instruction or imparting of information about the basic common tenets of all religions is disallowed. The Administration has further instructed that religious instruction in private schools, if provided, should be imparted outside school hour, to those students whose guardians give the necessary permission in "writing for such instruction.

SHRI DEOKINANDAN NARAYAN: Mn' I know whether all these schools are <"Jr>vernment administered schools schools run by Christian missionaries private agencies?

SHRIMATI LAKSHMI MENON: Manv of the schools are administered fev Christian Missions and private agencies.
