KANUNGO) : This Ministry's annual report for 1961-62 \*ai based on a review of the bicycle industry mad<sub>e</sub> in November. 1961, whereas the answer to the Parliament Question was based on facts available in June, 1962. Thus the reviews relate to different periods and therefore the latter supersedes the former.

They are disposed of expeditiously, and no proposal for changing the existing procedure is under consideration.
