(c) The remaining labourers are paid at local market rates prevailing in the area of recruitment, or in the absence of any such prescribed rates, at rates not exceeding the minimum o\* the authorised scales of pay plus dearness allowance divided by 30. If, however, the above rates are lower than the rates fixed under the State Government Minimum Wages Act in respect of employments comparable to "Scheduled employments" mentioned in that Act, then the rates prescribed in that Act shall apply.

Further those labourers whose employment is listed in the Schedule of the Minimum Wages Act (Central) are paid in accordance with the rates prescribed under that Act.
