t[THE MINISTER OF HEALTH (DR. SUSHILA NAYAR): (a) Yes, Madam.

- (b) The States Drugs Control authorities have already been alerted about the specified preparations and asked to take appropriate action.
- (c) The Union Territories have also been advised to take similar action in this regard.
- (d) The relevant recommendation aimed at bringing about uniformity in the standard of drugs manufactured, by centralising control on manufacture, sale, and distribution, now exercised by the State Drug Controllers, under the Drugs Controller (India). The Government of India not yet deemed it necessary to take this extreme step, but have placed the services of both the Central Research Institute, Kasauli, and the Central Drugs Laboratory, Calcutta, at the disposal of the State Governments to augment their testing facilities. The Government of India have also amended the Drugs Act providing for powers to Central Government to appoint Inspectors and Analysts, and to give directives to the State Governments for carrying into execution any provision of the Drugs Act and of any rule thereunder, wherever considered necessary. The question of appointing staff, etc. for this purpose is presently under the active consideration of the Government of India.]
