- (b) if so, what action has been taken by Government on the recommendations made by the said committee relating to the appointment of Assistant Welfare Officers, opening of a Central Consumer Cooperative Stores, appointment of Committees of residents in various colonies, financial assistance to Benevolent Funds and Canteens, Railway concession and opening of a holiday home for Government employees in Simla and providing certain amenities in Government quarters in the D.I.Z. area?

- (a) whether it is a fact that the Chief Welfare Officer had appointed Welfare Sub-Committees in each Government colony in New Delhi under the Chairmanship of Under Secretary (Wlfare);
- (b) if sc, whether any such committee was appointed in the Gole Market area also; and
- (c) if not, what steps are taken by Government to redress the day-to-day grievances of Government employees residing in this area?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI MARAGATHAM CHANDRA-SEKHAR): (a) to (c) Yes. Such Sub-Committees were set up, on a provisional basis, in August, 1960, in various localities including Gole Market area. Since then Welfare Clubs/Associations have started functioning in various localities and are ventilating the grievances of the Government employees.
