SHRI M. P. BHARGAVA: May I know whether it has come to the notice of the Education Ministry that certain news items have been published in the local newspapers that the milk meant for supply to the Delhi school children is being misappropriated by some teachers who are respon--puu Si IT pue \(\begin{align*}{c} i \) SurmqiJisip JoJ ajqis ing its way to the local markets?

SHRIMATI SOUNDARAM RAMA-CHANDRAN: That information is not correct because the milk powder for the Delhi school children is supplied through the Indian Red Cross Society whereas the complaint refers to the milk powder supplied by the UNICEF. So, it might have come from outside but no misappropriation inside Delhi has taken place.

SHRI M. P. BHARGAVA: Am I to take it that the Education Ministry has verified the facts the news item came to their notice?

SHRIMATI SOUNDARAM RAMA-CHANDRAN: Yes, this was verified. We received that information from the Health Ministry also that they received some complaints that milk powder has been smuggled by people but on enquiry it was found that it was milk powder supplied by the UNICEF and not by the Red Cross Society. We are making further enquiries into the matter.

SHRI M. P. BHARGAVA: What is the exact hitch in arriving a decision? Is it that the Ministry has found it advisable to refer the matter to the U. P. S. C. or the Law Ministry or some other Ministries?

SHRI B. N. DATAR: The difficulty is two-fold. They want an initial increase of Rs. 40 to Rs. 50 in the first instance. Secondly, they want a jump *al* about Rs. 145 in the seventh year. These are matters of great financial importance and therefore, some time is essential.

Shri M. P. BHARGAVA: May I know whether any reference to this question was made in the report of the Pay Commission and whether the demands of these Section officers are con. sistent or inconsistent with the recommendations of the Pay Commission?

SHRI B. N. DATAR: The Central Pay Commission made certain recommendations including the unification of the two grades, namely Grades II and III. It is on the basis of the recommendation of the Pay Commission that a common pay scale was laid down with certain efficiency bars. It is against this that the associations have been asking for such increase
