SHRI B. N. DATAR: No, Sir. That is not a correct approach.

UTHE DEPUTY MINISTER IN THE MINISTRY OF MINES AND FUEL (SHRI R. M. HAJARNAVIS): (a) The Jammu and Kashmir Government expects the reserves of this seam to be of the order of 100 million tons. The coal is of good quality approximating to selected grade 'B'.

(b) The Jammu and Kashmir Government have set up a Corporation called the Jammu and Kashmir Mining and Minerals Corporation, who are exploiting these reserves of coal. One mine at Bergoa with a yearly production of 1 lac tons has already been started this year. Project report for another mine at Sair has been completed envisaging yearly output of 1:5 lac tons.]

SHRI DAHYABHAI V. PATEL: Would the ordinary rules applicable to such corporations and enterprises in India in the matter of the companies law_t in the matter of labour and in the matter of their administration also apply to the mining operations in Kashmir or do they have a different set of rules?

SHRI R. M. HAJARNAVIS: That hardly arises out of this question. In any case the matter lies entirely within the authority of the Jammu and Kashmir Government and their lawmaking authority.

SHRI DAHYABHAI V. PATEL: May I submit that it certainly arises because they have dffferent laws ...

SHRI R. M. HAJARNAVIS: I have answered the question. It is entirely in the hands of the Jammu and Kashmir Government.

SHRI SITARAM JAIPURIA: Is railway siding available at the pithead and, if not, what would be the cost of transportation from the pithead to the railway siding?
