*492. SHRI V. M. CHORDIA: Will
the PRIME MINISTER be pleased to
state:

(a) the number of persons against
whom complaints have been received
by Government in regard to their in-
dulging in anti-Indian activities such
as destroying of Government proper-
ties or instigating other persons to
indulge in such activities since Goa
came under Indian possession;

(b) what action was taken against
such persons; and

(c) what steps were taken to incul-
cate faith in the Government of India,
in some of the people of Goa area by
removing the pro-Portuguese feelings
from their minds?]

वैदेशिक-कार्य मंत्रालय में उपमंत्री (श्री
दिनेश सिंह) : (क) से (ग) किन्हीं
व्यक्तियों द्वारा भारत-विरोधी कार्रवाइयां
करने के बारे में कोई खास शिकायतें नहीं आई
हैं। बहरहाल, इस संघीय प्रदेश के सामने
पुनर्वास की कुछ समस्याएं हैं और व्यापार,
रोजगार तथा विकास आदि के ऐसे मामले हैं
जिन पर शीघ्र और प्रभावकारी ढंग से
कार्रवाई करने की आवश्यकता है। भारत
सरकार इन समस्याओं पर पूरा ध्यान दे
रही है।

(SHRI DINESH SINGH): (a) to (c)
No specific complaints have been re-
ceived against any individuals in res-
pect of their indulging in anti-Indian
activities. The Union Territory is,
however, facing certain problems of
rehabilitation and there are matters
relating to trade, employment, devel-
opment etc., which need to be dealt
with quickly and effectively. The
Government are giving their full
attention to these problems.]

श्री विमलकुमार मन्नालालजी चौरङ्गिया :
क्या श्रीमन्, यह बतलाने की कृपा करेंगे कि
गोआ में भारत का कब्जा होने के पश्चात्
जो बम विस्फोट की कार्रवाइयां हुई थीं उसके
बारे में किस की जांच पड़ताल की और किमके
खिलाफ शिकायत पाई गई, या क्या हुआ ?

श्री दिनेश सिंह : उनकी जांच पड़ताल
हो रही है। काफियों की जांच पड़ताल हो
भी गई है। जिनकी अभी तक जांच हो गई है
उससे यह पता चला है कि यह किसी के किये
हुए काम नहीं थे बल्कि जो पुर्तगीज के छोड़े
हुए पुराने बम वगैरह थे वही वहां फटे हैं।

श्री विमलकुमार मन्नालालजी चौरङ्गिया :

मेरे प्रश्न के भाग (ग) का उत्तर स्पष्ट नहीं हुआ जो इस प्रकार है : गोआ क्षेत्र के कुछ निवासियों के मन से पुर्तगालियों के प्रति अनुकूल भावना हटाकर भारत सरकार के प्रति निष्ठा उत्पन्न करने के लिये क्या कदम उठाये गये ? क्या इसका जवाब देने की कृपा करेंगे ?

श्री दिनेश सिंह : इसकी जरूरत नहीं है क्योंकि गोआ के जो निवासी हैं उनका दिल भारत की ही तरफ है ।

SHRI BHUPESH GUPTA: May I know, Sir, if the Government is aware of any activities directed against the new authorities established there now. He said no complaint has been received against an individual, but is he aware of such activities going on in that part of the country?

SHRI DINESH SINGH: Matters in connection with any activities that may go on about any individual, that we have not covered in this question.

SHRI BHUPESH GUPTA: That is not the point. My question was: Is he aware of any such activities directed against the authorities there going on? If so, is there any presumption that some people must be responsible for such activities? And if this presumption is there, what steps did the Government take in order to find out the people?

SHRI JAWAHARLAL NEHRU: I suppose the hon. Member refers to some kind of an organised activity. As far as an individual says something, well, action against him depends on what he says and how he says it. There is no organised activity as such. There were, as my colleague has said, a number of bomb explosions. The enquiry into them is not yet quite complete, but it is clear that

they were the bombs the Portuguese had left with the intention of blowing up some place, but they had to leave rather in a hurry. So these bombs later exploded. The report has not yet been finalised.

SHRI BHUPESH GUPTA: It seems that these bombs that are exploding there are not likely to be time bombs, as far as we can make out, that they are left by the Portuguese and that they seem to be exploded by some people there. And is it not a fact, Sir, that there were many henchmen of the Portuguese there and that some of them are trying to get into the key positions in the administration? Is the Prime Minister aware of such things?

SHRI DINESH SINGH: Most of them as I mentioned, exploded by accident, someone running over them or touching them.

SHRI N. C. KASLIWAL: It appears from press reports that the Cardinal of the Portuguese Church had decided to stay in Goa after Goa's liberation but that he is going away now. So, may I know, Sir, whether he is going away out of his own volition, or Government have asked him to leave the country?

SHRI DINESH SINGH: I think the hon. Member is referring to the Portuguese Patriarch in Goa. I believe a new patriarch is coming to replace him.
