IMPORT OF MARINE DIESEL ENGINES
WITH JAPANESE YEN CREDIT

- (b) if so, the number of engines likely to be procured and their cost; and

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD (SHRI A M. THOMAS): (a) Yes.

- (b) About 400 engines at an estimated cost of Rs. 42 lakhs.
- (c) Yes, but these are mainly for stationary application. Marine diesel engines are in the process of being developed by three firms in the country and they are not in a position to meet the demand for these engines at present.
