

**CONTRACTS GIVEN TO NATIONAL BUILDINGS  
CONSTRUCTION CORPORATION**

♦608. SHRI R. N. KAKATI: Will the Minister of WORKS, HOUSING AND SUPPLY be pleased to state:

(a) whether instructions have been issued to the CP.W.D. authorities that encouragement should be given to the National Buildings Construction Corporation by awarding construction works; and

(b) if so, the number of contracts awarded by the CP.W.D. to the National Buildings Construction Corporation during the years 1960-61 and 1961-62?

THE MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI MEHR CHAND KHANNA):

(a) No. But the National Buildings Construction Corporation are being awarded works on a competitive basis and consistent with their capacity.

(b) The information is being collected and will be laid on the Table of the Sabha. It may, however, be stated that contracts of the approximate value of about Rs. 3 crores have been given by the CP.W.D. to the National Buildings Construction Corporation up till now.

**HORTICULTURAL OPERATION IN CENTRAL  
VISTA**

(a) whether any horticulture work is in operation in the Central Vista, New Delhi; and

(b) if so, what are the details thereof?

THE MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI MEHR CHAND KHANNA):  
(a) and (b) In implementation of one of the recommendations

of the *Ad hoc* Committee on Sub-soil Water Table Conditions in New Delhi, the Central Vista lawns measuring about 100 acres are being regraded at an estimated cost of Rs. 6\*44 lakhs. The work of regrading the lawns has been taken up to ensure quick drainage of rain water and to arrest the rise of sub-soil water table in the area.
