

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) and (b) Schemes for over/underbridge in replacement be sponsored by the State Government. The Railways undertake such works whether the State Government recommend and provide necessary funds towards their share of the cost.

Proposals for over/underbridges in replacement of existing level crossings, recommended by the Government of Madhya Pradesh for the Third Five Year Plan, include one road overbridge at Bhopal in replacement of the level crossing at mile 519/16 and another road overbridge on Morena Mahagaon road at mile 0/4.
