SHRI NAWAB SINGH CHAUHAN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state the suggestions made last year by various Programme Advisory Committees of Akashvani, Delhi and how many of them have been implemented and how many have not so far been implemented and what is the reason therefor?]

सूचना तथा प्रसारण मंत्रालय में उपमंत्री (श्री शाम नाथ) : आकाशवाणी के दिल्ली केन्द्र से संलग्न प्रोग्राम एडवाइजरी कमेटी ने अपनी १९६१ में हुई बैठकों में संगीत, ड्रामा, राष्ट्रीय एकता और एकीकरण सम्बन्धी कार्यक्रम, साहित्यिक कार्यक्रम इत्यादि से सम्बन्धित निम्नलिखित सुझाव और सिफारिशों की :-

१. भारतीय संगीत पर पाठों का आरम्भ करना और उनका पर्याप्त प्रचार करना ।
२. संगीत समीक्षा कार्यक्रमों का प्रसारण करना ।
३. ब्रज क्षेत्र की परम्परागत शैली की रास लीला में उपयुक्त पदों को शामिल करना ।
४. मुगम संगीत के साथ अत्यधिक संगत बचाना; अधिक कोरस गीतों का प्रसारण करना; और गज़लें गाने के लिए केवल उन्हीं कलाकारों को अवसर देना जो उनका अर्थ समझने हों ।

५. सामान्य कार्यक्रम में ब्रज गीतिनाट्य का प्रसारण करना ।

६. राष्ट्रीय एकता और एकीकरण पर कार्यक्रमों का प्रसारण करना ।

७. दक्षिण भारतीय भाषाओं में पाठों का प्रसारण करना ।

८. जामूसी कहानियों या रोमांचकारी कथाओं पर आधारित अधिक नाटकों का प्रसारण करना ।

९. मासिक साहित्यिक कार्यक्रम "रचना" को और अधिक बार प्रसारित करना ।

१०. उर्दू कार्यक्रमों विशेषकर गज़लों और उर्दू गौरव-ग्रंथों को प्रस्तुत करने में सुधार करना, और महान किस्सा-गो बाकर अली के बारे में कार्यक्रम का प्रवन्ध करना ।

इन सभी सिफारिशों को या तो कार्यान्वित किया जा चुका है या उन्हें कार्यान्वित करने के लिए स्वीकार कर लिया गया है ।

†[THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SHAM NATH): The Programme Advisory Committee attached to the Delhi Station of All India Radio made the following suggestions and recommendations relating to music, drama, programmes on national unity and integration, literary programmes, etc. at its meetings held in 1961:—

1. Starting of lessons in Indian music and giving them due publicity.
2. Broadcast of music appreciation programmes.
3. Inclusion of suitable Padas in the traditional style of Raas Leela of Braj area.

4. Avoiding excessive accompaniment to light music; broadcast of more chorus songs and allowing only those artists to sing ghazals who follow their meaning.

5. Broadcast of Braj operas in the general programme.

6. Broadcast of programmes on national unity and integration.

7. Broadcast of lessons in South Indian languages.

8. Broadcast of more plays based on detective stories or thrillers.

9. Increase in the frequency of the monthly literary programme "Rachna".

10. Improvement in the presentation of Urdu programmes, particularly in the presentation of ghazals and Urdu classics and arranging programme about the great story-teller, Baqar Ali.

All these recommendations have either been implemented or have been accepted for implementation.]

TRANSFER OF BERUBARI TO PAKISTAN

33. SHRI A. B. VAJPAYEE: Will the PRIME MINISTER be pleased to refer to the answer given to Starred Question No. 64 in the Rajya Sabha on 25th April, 1962 and state:

(a) whether formalities for the transfer of Berubari to Pakistan have since been completed;

(b) if not, what are the reasons for the delay; and

(c) whether any scheme has been prepared for the resettlement of families which are likely to be uprooted as a result of the transfer?

THE PRIME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) No Sir.

(b) The principal reason for the delay in the survey and demarcation of

the area is that the East Pakistan authorities are not prepared to give the assurance that Indian survey personnel will not be liable to search or arrest while they are temporarily on East Pakistan territory in connection with the survey work. Such an assurance was considered necessary after the Darsana incident in November, 1961, when two Indian Survey officers were arrested by Pakistan authorities.

(c) Schemes for the rehabilitation of persons who are likely to leave that portion of Berubari Union which may be transferred to Pakistan, are under consideration by the Government of India in consultation with the Government of West Bengal.

MANUFACTURE OF PORTABLE TYPEWRITERS
