(b) Export incentives are granted in the shape of import entitlements of (i) raw cotton and textile machin ery, (ii) dyes and chemicals etc. While mills are entitled for both (i) and (ii), the exporters and processors are «ntitled for (ii) only. The quantum of the incentives vary according to the nature of textile exported i.e. whether grey, bleached, processed or printed.

"HATE-INDIA" CAMPAIGN IN PAKISTAN

•31. SHRI A. M. TARIQ: Will the PRIME MINISTER be pleased to state:

(a) whether it i_s a fact that Pakistan has started a "Hate-India" campaign in Pakistan as well as outside Pakistan; and

(b) if so, what action the Government of India have taken to counteract this campaign?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Yes, Sir. From time to time a 'Hate-India' campaign is whipped up in Pakistan. Recently the campaign resulted in the out-burst of violence against members of the minority community in East Pakistan. Abroad also Pakistan's propaganda has been directed mainly towards undermining the secular character of India with a view, obviously, to establishing Pakistan's claim to Kashmir on religious grounds.

(b) Our Missions abroad constantly endeavour to provide correct facts about India to people in their respective areas. Whenever necessary specific contradictions of Pakistan's propaganda are put out. Our Missions have been using all available media of publicity to explain India's secular character and to interpret our internal and external policies. It would not be correct to assume that Pakistan's propaganda against India has succeeded in any great measure.

B.B.C. TELEVISION PROGRAMME ON OCCUPIED KASHMIR

*32. SHRI A. M. TARIQ: Will the PRIME MINISTER be pleased to state:

(a) whether Government are aware that the B.B.C. televised a programme on occupied Kashmir on the 7th of April, 1962;
