THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) The beach sands of Kerala contain a number of minerals. Some of these are of importance to the Atomic Energy programme and their mining and trade are governed by the Atomic Energy Act (Act No. XXIX of 1948), and the Orders issued thereunder.

(b) and (c) The only private company which has closed down production in recent years is Messrs. Hopkin & Williams (Travancore) Ltd. Government do not have any proposals at present for taking over and running the factory of this Company.

(d) As far as Government are aware, the management of Messrs. Hopkin & Williams (Travancore) Ltd. does not propose to restart its factory.

(क) स्टेट ट्रेडिंग कारपोरेशन द्वारा १९६१-६२ के वित्तीय वर्ष में २३० टन कपूर का आयात किया गया। प्रत्येक राज्य में जिन व्यक्तियों को कोटा दिया गया उन सब की सूची तैयार करने में समय लगेगा। यह जानकारी इकट्ठी करके यथा समय सभा की मेज पर रख दी जायगी।
