पहले दर्जें के यात्रियों के लिए गाड़ी में साथ चलने वाले परिचर

महत्वपूर्ण मुख्य मार्गी पर चलने वाली गाड़ियों के पाले दर्जे के गलियारेदार डिब्बों में परिचर नियुक्त करने का फैसला किया गया है।

परिचरों के मुख्य कतंव्य इस प्रकार हैं :-

- (१) बाहरी दरवाजों को बन्द करना, दूसरे यात्रियों को गलियारे या दरवाजे में बैठने से रोकना, शायिकाएं खाली होने पर अन्दर माने वाले मात्रियों के लिए दरवाजे बोलना।
- (२) सफ़ाई ग्रीर डिब्बों की फिटिंग पादि के सम्बन्ध में यात्रियों के घाराम का भ्यान रखना।
- (३) यात्रा करते हुए ,यात्रियों स्रोर खाली जगहों का ज्योरा ,रखना ।

पे रवरों को ७५-१-८५ कु॰रो॰-२-८६ रुपये के ग्रेड में रखने का विचार है और ऐसी संभावना है कि उत्तर रेलवे में २-३ महीमें के श्रन्दर इन की निय्कित हो जायेगी।

STATEMENT

Travelling Attendant for First Class Passengers

It has been decided to appoint "Attendants" in the corridor type first class coaches on trains on important trunk routes.

The more important duties of the 'Attendants' are as under:—

(i) To secure the outer doors, prevent other travellers occupying the corridor/entrance, open the doors for passengers

- to be accommodated in the vacant berths.
- (ii) To attend to the comforts of the passengers relating to cleanliness, fittings of coaches etc.
- (iii) To carry details of passengers travelling and the vacant accommodation available.

The 'Attendants' are proposed in the grade Rs. 75—1—85—EB—2—89 and are likely to be appointed on the Northern Railway in 2 or 3 months time.]

FOODGRAIN WAREHOUSES

228. SHRI KRISHNA CHANDRA: Will the Minister of Food and Agriculture be pleased to state:

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) 57 warehouses of the Central Warehousing Corporation are in actual use and are located at the places shown in the attached statement.

- (b) and (c) 46,222 Metric Tonnes of foodgrains were stored on 31st March, 1962. Separate figures for the stock stored on behalf of actual producers are not available.
- (d) The total advances outstanding against warehouse receipts issued to the warehouses as on 25th January, 1962 stood at Rs. 1.21 crores. Separate figures of advances made by
