## [RANCHI-GAYA TELEPHONE LINE

(b) whether there is any scheme for introducing direct telephone connections between Patna and Ranchi and Ranchi and Delhi; if so, by when the work in this connection will start;

(c) whether direct telephone connections exist between Bhagalpur-Patna and Bhagalpur-Delhi; and

[THE DEPUTY MINISTER IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI B. BHAGAVATI): (a) An 8-channel carrier telephone system will be installed between Ranchi and Gaya before the end of August 1962.

(b) Direct Trunk Telephone circuit between Patna and Ranchi already exists. There is no proposal for a direct trunk circuit between Ranchi and Delhi.

(c) Direct trunk telephone circuit between Bhagalpur and Patna already exists. There are no proposals for a direct trunk telephone circuit between Bhagalpur and Delhi.

(d) Direct trunk circuits between Bhagalpur and Delhi are not justified.]

#### STEALING OF OVERHEAD WIRES BETWEEN ADI SAPTAGRAM AND MAGRA STATIONS

Adi Saptagram and Magra on the Eastern Railway was stolen and in consequence thereof, the down trains on the electrified section of the railway were delayed much beyond their scheduled time?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI S. V. RAMASWAMY): Yes, Sir. The incident occurred in the early hours of 4.5.62, when both contact and catenary wires in one span of two adjacent structures between Adi Saptagram and Magra stations were found to have been cut and stolen.

#### METHODS OF TEACHING MEDICINE

#### STATEMENT

The President of the Medical Council of India in his Presidential address-delivered at the 57th Session of the Council *inter alia* observed that in the revised Under-graduate Medical Curriculum, drawn up for consideration of the Council, importance had been laid on the study of Social and Preventive Medicine and more emphasis was to be given on seminars, discussions, conferences, clinical and practical teaching than on didactic lectures. He felt that with the changes made in the curriculum and re~
