orientation in teaching methods. it would be possible to produce doctors better trained and equipped than now. As the respective Universities are concerned with the curriculum, it is for them to consider the recommendations which will be forwarded to them by the Council.

DHRUVARAN THERMAL POWER PLANT

◆254. SHRI M. C. SHAH: Will the Minister of IRRIGATION AND POWER be pleased to state what decision has been taken On the request of the Government of Gujarat that the Thermal Power Station at Dhruvaran should have double the proposed capacity to meet the extreme shortage of power in the State?

The manner in which Panchayats and Panchayati Raj institutions are functioning is under constant review by the State Governments as also the Central Government, and every endeavour is being made to devise suitable remedial measures after careful study.
