A foot over-bridge at Kalunga has been extended for the doubling.

SHRI SHAH NAWAZ KHAN: I shall require notice. But I may tell the hon. Member that we have to con. struct footoverbridges at nine other stations and may be Bamra is one of them

ing opened at Jorbagh which must improve the situation in the Southern part of New Delhi. And another is going to be opened near Delhi Gate and that should also improve the situation in Connaught Pliace and the Old Delhi area.

SHRI BABUBHAI CHINAI: In view of the fact that complaints about the Telephone Department are pouring in from all parts of the country, is it the intention of the Government to appoint an enquiry committee to find out what the complaints are and what are the remedies?

SHRI J AG JI VAN RAM: An enquiry committee might be necessary if the causes are not known. Enquiry committee has become a slogan with some vested interests in the country. "We know the causes and we know the remedies. The causes are known and the remedies are also known. It is the shortage of resources that is standing in the way and as soon as we have the resources all these defects will be removed.

SHRI BABUBHAI CHINAI: Are the complaints only from the vested interests as the hon. Minister was referring just now, or are they from all the consumers or users of the telephone system?

SHRI JAGJIVAN RAM: This slogan for an enquiry committee has arisen from a section of the vested interests.

SHRI K. SANTHANAM: Is the hon. Minister aware that the persons in charge of the phonograms at the Delhi offices are not able to take any kind of dictation in English?

SHRI JAGJIVAN RAM: I am aware and we have to repeat the words several times, and sometimes we have to give them the spelling also. Action is being taken to improve the effi-I ciency of the staff.
