(b) Yes, Sir. Approval has been given for the construction of buildings for six major laboratories at a total cost of Rs. 7.04 crores.]

SHRI M. P. BHARGAVA: May I know whether it is a fact that some of these Research and Development establishments duplicate the work of some other laboratories which are carrying on similar work?

SHRI K. RAGHURAMAIAH: There is no question of duplication. It is a question of specialisation.

SHRI K. SANTHANAM: What are the arrangements for co-ordination of the research establishments of the Defence Ministry with those of C.S.I.R.?

SHRI K. RAGHURAMAIAH: have already a Research and Development Establishment in our Ministry which co-ordinates all the various researches in the various laboratories.

SHRI JAI NARAIN VYAS: May I know why the expert resigned? What was the basis? Has he resigned for want of accommodation? There must be some reasons.

SHRI K. RAGHURAMAIAH: I am sorry. I did not know that the question related to the resignation of an expert. I should like to have notice.
