have been arrested in connection with these bomb explosions and, if so, what is their number?

Oral Answers

SHRI B. N. DATAR: I have not got the particular nationalities of the persons who were arrested.

SHRI FARIDUL HAQ ANSARI: In view of the fact that these incidents have been happening in the Capital for the last five years, may I know whether the Government is prepared to make some arrangement or find out some method to ascertain why these things are happening in a particular locality?

SHRI B. N. DATAR: They are not particularly confined to a particular locality; they are in different parts of Delhi city.

SHRI B. K. GAIKWAD: May I know how many persons were injured in these bomb explosions and whether the Government has found any clue as to where such bombs were manufactured? May I also know whether this bomb was manufactured in the Government factory?

SHRI B. N. DATAR: Sir, so far as the incident of 14th May was concerned, ten persons, including four children and three women, were slightly injured. So far as the incident of 15th May is concerned, none was iniured.

SHRI M. P. BHARGAVA: May I know whether the hon. Mnister is aware whether any foreign national has so far been arrested in connection with these bomb explosions?

SHRI B. N. DATAR: I am not aware. Sir.

SHRI A. D. MANI: Do these investigations go to show that there is a possibility of a suspicion at least that foreign nationals are involved in these bomb explosions?

SHRI B. N. DATAR: I have already stated

to Questions MR. CHAIRMAN: He has already stated

SHRI A. D. MANI: But it is said . . .

MR. CHAIRMAN: He said that an enquiry is being made.

SHRI NIREN GHOSH: In view of the numerous incidents that have been happening in the Capital, may I know whether Government would give this issue top priority with all the resources at its disposal so that they can put a stop to this sort of things happening in Delhi?

SHRI B. N. DATAR: Government are giving their fullest attention to this but it should also be noted that a very large number of these casej were only cracker explosions. Only in five or six cases they were fairly serious and Government are fully seized of the urgency of looking into all these matters.

SHRI AKBAR ALI KHAN: In the case of bomb explosions, could you say where they were manufactured or made?

SHRI B. N. DATAR: Sir, it is very difficult to say where they were made.
