- (b) The Assam Government have objected to the mode of determining well head value as provided in the Second Supplemental Agreement of 27th July, 1961.
- (c) the existing rules do not contemplate consultation with the State Government in regard to agreements for development of oil resources.

FOREIGN PRIVATE INVESTMENTS

326. Shri NIREN GHOSH: Will the Minister of Finance be pleased to state:

- (a) the total amount of foreign private investments as on 31st March, 1962 or the nearest date for which complete figures are available;
- (b) the total amount of profit made by foreign private companies between 1950-51 and 1960-61 and the amount of profit taken out of India during the same period; and
- (c) whether Government propose to put any ban on taking such profits out of India?

THE MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) The latest date upto which information has been compiled is 31st December, 1959. The total amount of foreign investments

in India as on that date was Rs. 610.7 crores. The figures as on the 31st December, 1960 are expected to be available shortly.

- (b) The amount of Rs. 155.4 crores was earned by non-residents as their share of profits in foreign controlled companies in India during the years 1956 to 1959. Out of this amount Rs. 101.5 crores were distributed as profits to non-residents and the balance of Rs. 53.9 crores was retained in business by such foreign controlled companies. Similar figures for the years prior to 1956 and subsequent to 1959 are not available.
