SHRI K. RAGHURAMIAH: That is a very long question and I have not been able to follow most of it but I would like to say that the Government would take everything into account.

†[THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY INDUSTRIES (SHRI P. C. SETHI): (a) The main topics of discussions held at Bonn in May 1962 were the finalisation of the draft report of the Solveen Delegation and the measures necessary to bring Rourkela a Steel Plant to its full production capacity.

(b) As a result of the discussions, remedial measures have been agreed upon and arrangements for putting them into effect are already in hand.]

SHRI LALJI PENDSE: Sir, the answer was read out too fast. We could not follow anything.

MR. CHAIRMAN: It was not too fast because I could follow it. You may again read it.

श्री पी० सी० सेठी : मशीनरी को रिपेयर करने का काम किया जा रहा है और रिपोर्ट में जो कुछ सुझाव दिया गया था उसके सम्बन्ध में भी कार्यवाही हाथ में ली गई है।

श्री विमलकुमार मन्नालालजी चौरङ्गिया :
क्या माननीय मंत्री महोदय बतायेंगे कि वहां जो विदेशी फर्म थी उन्होंने अपने शासन को क्या रिप्रेजेंटेशन दिया था और उसमें क्या क्या आरोप लगाये थे कि ये असुविधाएं हो रही हैं इसलिये हम अपना सहयोग वापस लेना चाहते हैं ?

श्री पी० सी० सेठी : रिपोर्ट में मुख्य मुख्य बातें ये बताई गई हैं : आवश्यक प्रशिक्षित टेक्निकल स्टाफ की कमी है, दूसरे, संयंत्र की देखभाल, स्तर के अनुसार नहीं रखी गई है, तीसरे, कच्चे माल की क्वालिटी हल्की थी। उन्होंने यातायात व्यवस्था की खामी पर भी जोर दिया है और साथ ही इस बात को भी स्वीकार किया गया है कि जो फर्म्स ने सामान आदि दिया था उस सामान के कुछ हिस्से आवश्यक अपेक्षा के अनुसार नहीं आये हैं।

SHRI A. D. MANI: Sir, I would like to ask whether in the discussions at Bonn there was any attempt on the part of the German engineers to throw the responsibility for the failure of the Rourkela plant on the Indian engineers and, if so, what was the reply that our representative gave to such allegations?

SHRI C. SUBRAMANIAM: There was a discussion with regard to the defects and deficiencies found in the plant and, as already pointed out by

the Deputy Minister, the points made in the Solveen Committee Report, related to various deficiencies, one of them being the deficiencies in the plant itself.

SHRI BAIRAGI DWIBEDY: May I know, Sir, whether the expansion of the plant in the Third Five Year Plan, before the plant can work to its full capacity, has been discussed?

SHRI C. SUBRAMANIAM: Yes, Sir, incidentally that was also discussed.

SHRI SUDHIR GHOSH: It is a fact that during these discussions in Bonn the West German authorities pointed out to our people that since the present organisation is not in a position to use the present million-ton plant to more than 35 per cent., or whatever the capacity is that is being used, it would be unwise first to double the one million-ton capacity or raise it to 1.8 million tons without making sure that the present one-million capacity is fully worked?

SHRI C. SUBRAMANIAM: Yes, Sir, they have suggested means to rectify the mistakes so that the full million production capacity could be achieved, and naturally they expressed some concern about the shortfall in the production now, and so before we take up the expansion programme, the other thing should be looked into and we are giving the first priority to rectify the mistakes and therefore the expansion programme also is likely to go through as scheduled.

SHRI SUDHIR GHOSH: When the Minister or the Secretary says in a public statement that within six months or some reasonable period the plant will reach optimum production, does it mean 35 per cent. or 45 per cent. of the total? What do they really mean by 'optimum production'?

SHRI C. SUBRAMANIAM: Out of the three blast furnaces only two blast furnaces are working just now.

The third one which was inactive had been completely repaired and it would go on stream again some time next month or in early August. With the two blast furnaces functioning we are able to produce about 50,000 tons of steel, and that would mount up to 600,000 tons of steel per year when two blast furnaces alone are producing pig iron. From that the hon. Member might calculate and find that it is more than 80 per cent. taking into account that two blast furnaces are only functioning now.
