indications about the existence of coal in the Nuzvid Taluq of Krishna District have recently been inferred by the Geological Survey of India from a few boreholes drilled for water by private agencies.

- (b) In the Nuzvid taluq the boreholes in which indications for coal have been found are situated over a length of about 3i miles (5-6 kms). The extent of the possible coal bearing area has not yet been determined.
