

**LOCK-OUT IN H.S.L., ROURKELA**

'SHRI S. PATEL: \*2 J SHRI LOKANATH MISRA: 1 SHRI NIREN GHOSH: \_ SHRI GOVINDAN NAIR:

Will the Minister of STEEL AND HEAVY INDUSTRIES be pleased to state:

(a) whether there was recently a lock-out in the Hindustan Steel Limited, Rourkela; and if so, the amount of loss sustained thereby;

(b) what were (i) the reasons for the lock-out and (ii) the demands of the workers; and

(c) what action was taken by Government to resolve the dispute and the result thereof?

THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM) :

(a) Yes, Sir. Hindustan Steel Limited have estimated the loss on account of the recent lock-out at Rs. 78 lakhs approximately.

(b) and (c) The reason for the lockout was an illegal sitdown strike launched without any notice by about 500 workers of the Blast Furnace Department. It was apprehended that the illegal strike might spread to other

Departments. There was also the possibility of the situation taking a violent turn with danger to life and property.

The demands of the workers were largely for increase in wages and promotion to higher posts. A committee was appointed by Hindustan Steel Limited to look into the grievances of the workers and orders regarding promotions wherever due have been issued.
