THE MINISTER OF INTERNATIONAL TRADE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI MANUBHAI SHAH): (a) and (b) Authorised Controllers have been appointed for the Model Mills, Nagpur and the Mohatta Mills, Akola, with effect from the 18th July, 1959 and the 15th September, 1961 respectively. They will hold office for a period of five years from the date of their appointment.
