ENCROACHMENT UPON TOMB OF SHAH ABDUL AZIZ

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION AND POWER (SHRI O V ALAGESAN): (a) There has been no encroachment on the tomb of Shah Abdul Aziz Dehlawi but a portion of the contiguous land comprised in Qabrastan Mehdiyan has been encroached upon by some dhobis.

(b) The graveyard is under the supervision of the Sunni Majlis-e-Aukaf, Delhi, and they have been advised to take necessary action in consultation with the Delhi Administration to evict the trespassers.
