- (b) whether the railway authorities have any proposal for providing fans there and if so, by what time the proposal is likely to materialise?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) Due to commitments already entered into in respect of the limited funds available, this proposal could not be considered earlier.

(b) Yes Sir, fans are expected to be provided in about a month's time.

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNITY DEVELOPMENT, PANCHAYATI RAJ AND COOPERATION (SHRI B. S. MURTHY): The Ministry has no knowledge of such an agreement.

# ORGANISATION TO EVALUATE HEALTH PROGRAMMES

- 297. DR. A. SUBBA RAO: Will the Minister of HEALTH be pleased to state:
- (a) whether the Government of India propose to set up an indepen-

dent organisation to continuously evaluate health programmes in the country;

- (b) if so, when it will be set up; and
- (c) what will be the personnel of the proposed organisation?

THE MINISTER OP HEALTH (Da. SUSHILA NAYAR): (a) to (c) A schema for the establishment of an organisation for training and research in public health practice including evaluation of health programmes is under consideration, but it is not possible to say at this stage when a final decision in the matter is likely to be taken, and what will be the personnel required for the purpose.

### HEART DISEABS

- 298. DR. A. SUBBA RAO: Will th\* Minister of HEALTH be pleased to state;
- (a) whether it is a fact that the incidence of heart disease in the country is on the increase during th\* last decade; and
  - (b) if so, the reasons therefor?

THE MINISTER OF HEALTH (DR. SUSHILA NAYAK): (a) and (b) Rel'able data are not available. However, the incidence of Heart Diseases appears,to be on the increase. While this may be partly accounted for by better reporting and diagnosis of this type of cases, the increased complexity and stresses of modern ways of life particularly in urban areas could also be important factors.
