

## STATEMENT

(a) The target of 7,000 maunds of milk to be handled per day is expected to be achieved in 1964 by the Delhi Milk Scheme.

(b) The following measures have been adopted to achieve the target:—

(i) Increased production of milk in rural areas surrounding the city is being fostered by regular off-take of milk at an attractive price by the Scheme.

(ii) Cattle purchase loans to enable milk producers to buy more and better milch animals have been granted.

(iii) The Scheme is implementing a programme to set up 30 milk Collection and Chilling Centres, each capable of handling 400 maunds of milk daily, in the rural areas of U.P., Punjab and Delhi surrounding the Capital City.

(iv) Procurement and transport of Cow Milk from Bikaner has been taken up.

(v) A Central Dairy to process and bottle milk and manufacture products from surplus milk has been established with the necessary equipment which is being augmented as the supply of milk is increasing.

(vi) A chain of milk depots and All-Day Milk Shops has been set up to sell milk and milk products in different parts of the city and their number is being increased with the increase in supply of milk.]
