

DR. K. L. SHRIMALI: Well, Sir, the terms of reference are that the Committee has been asked to prepare model legislation for all the Universities. Now we have different kinds of legislations and sometimes they vary from State to State and from University to University. The University Education Commission which was presided over by our Chairman had laid down certain principles with regard to the composition of various academic bodies in the Universities. Several universities have not yet implemented those recommendations and therefore this committee will not only keep those recommendations in view but the subsequent reports also, and in the light of these recommendations prepare a model legislation for the universities, which can be of advantage to all the universities, and the model legislation, naturally will deal with the composition of the court, the composition of the executive council, the composition of the selection committee and the composition of other academic bodies.

(c) if the answer to part (a) above be in the negative, by when the report is likely to be finalised?]

DR. K. L. SHRIMALI: The Delhi University has evening colleges, and as far as I know, there are one or two other universities which have also evening colleges, but this is subject to correction.

SHRI N. SRI RAMA REDDY: May I know, Sir, whether these evening colleges are having only the pre-university course and then the degree course, and may I know also what other courses are included in these evening colleges?

DR. K. L. SHRIMALI: Well, Sir, the evening courses include the pre-university course also, and at present they have only arts courses; they do not have science courses. But there is a proposal to expand the scope of this scheme and this committee will look into that matter also.

SHRI BAIRAGI DWIBEDY: May I know, Sir, whether the correspondence courses and the evening courses are to be managed by the existing staff?

DR. K. L. SHRIMALI: All these details will have to be worked out by the Delhi University and when the

scheme has been fully worked out, I shall be very glad to give this information to the hon. Members.
