(e) The Government have decided to-explore'possibilities of commodity loan of wheat to SAARC countries or other countries, as also barter trade of wheat with those countries which could supply us other commodities in exchange of wheat at prices at which they are importing wheat from other countries. It has also, been decided to allow export of wheat on Government .to Government account subject to suitable floor price. However, no specific quantity of wheat has been fixed for export.

(d) if so, the details thereof?

SHRI" SHRIRAM CHAUHAN): (a) and (d)Government has authorized Food Corporation of India-to sell upto 5 million tonnes of wheat in Punjab only Open Market Sale Scheme (Domestic) during the months of July, August and September, 2000 at the following rates:

Month	Rate
July, 2000	Rs. 700/- per qtl.
August, 2000	Rs. 750/- per qtl.
September, 2000	Rs. 800- per qtl.

However, the issue price of wheat under this scheme in the rest of the country remains the same *i.e.* Rs. 900/- per qtl.

(c) The quantities of wheat and rice allotted to lifted by various State/UT. Administrations under PDS during April to June, 99 and 2000 are given in the enclosed Statement (*See* below).

(d) The lifting of foodgrains has decreased during the said months in the current year as compared to the similar months of previous year. Allocation under BPL quota has almost been doubled as compared to the previous year. The lifting of rice against BPL allocation is showing increasing trend as compared to previous year in the said months.
