LINGAM: Sir, may 1 know if the Government is aware that a nonofficial body like the Indian Institute of Applied Economic Research has come out with a report indicating the broad distribution of the income generated in the Plan period in India? If so, what insurmountable difficulty a Government body like the Committee which the Government have appointed has found to come out with a report, since such a report is vital not only to frame our fiscal and monetary policies but also to determine the future of planning in India as a whole?

SHRI GULZARILAL NANDA: It may be easy for someone to bring out a report in a single day but we are concerned with a report which is going to be put before the nation, and conclusions will be drawn from it. It will have large implications and therefore I do not think that any hurry will be really useful in a matter like this.

SHRI K. SANTHANAM: If the Government Committee takes so much time, may I know if the report will not be out of date by the time it is submitted?

SHRI GULZARILAL NANDA: No, Sir. A report which is taking so much time for the collection of data, which touches all the fields of the economy in the life of the nation, is not going to be soon out of date.

SHRIK. SANTHANAM: What will be the basic year for which the data will be collected?

SHRI GULZARILAL NANDA: It will actually depend upon the availability of the data which may differ for different regions.

SHRI M. RUTHNASWAMY: Am I to understand that even no outside timelimit is to be imposed for the report of technical commit1e°s?

SHRI GULZARILAL NANDA: As I indicated already, some kind of draft is ready now. It is going to be considered very soon by this Committee. Now, the economists may find that the material before them is not quite adequate. They may want something more. That might require a little more time. If this data is considered adequate, then I do not think it will need much more time. In a few months we should have that report.

SHRI M. S. GURUPADA SWAMY: The hon. Minister has said that the Committee has met only five times though it was set up a long back, and the members of the Committee are not able to find time to meet more than five times. Would it not be advisable, in view of this, to enlarge the Committee or to change the personnel of the Committee?

SHRI GULZARILAL NANDA: The difficulty is not about suitable personnel and we do not judge the quality of the work of a Committee like this by the number of meetings it holds. In one single meeting numerous directions are given for the collection of data from a number of sources. Various persons, various institutions or agencies are employed for that purpose and when the material is there, they go and look at it.
