as the persons have been released, there, so far a_s we are concerned, the matter ends. We do not wish to carry this any further.

SHRI SATYACHARAN: May I know whether while considering the question of the repatriation of the Portuguese nationals, the Government of India have also considered the lot of the Indians interned i_n Mozambique and other Portuguese territories?

SHRI JAWAHARLAL NEHRU: We have considered it repeatedly and we are still considering it but we do not tie it up with the return of the Portuguese internees, the military internees chiefly, in Goa. I forget the number— it is between three and four thousand, the Portuguese military and a few civilian personnel connected with Ihe army that were detained in Goa after the operations. We made it clear that they are perfectly free to go and that the Portuguese Government could make its own arrangement to take them away, and we are still waiting for them to take them away. They can go away regardless of any other factor. We deal with it separately and we shall continue to deal with it. But we do not want to make it a bargaining point with Portugal.

PANDIT S. S. N. TANKHA: In one of the communications which was sent by the Portuguese Government some time back, it was stated that some of those persons who were arrested and were living in the other possessions of the Portuguese would not be allowed to return to those places, and upon that the Government of India, I believe, made some representation to the Portuguese authorities that there was no reason why they should not be allowed to return to the country where they were living. I would like to know from the Prime Minister if he has received any reply from the Portuguese Government on that point.

SHRI JAWAHARLAL NEHRU: I have not understood who are some of those persons, Indian, Portuguese, what, where?

PANDIT S. S. N. TANKHA: Indians who were living in Portuguese possessions, other than Daman, Diu and Goa.

SHRI JAWAHARLAL NEHRU: The Portuguese took up an attitude originally that because they were in a kind of state of war with India they were entitled to intern all Indian nationals in their colonies, but then lately they have said that they should return to India; they want them to return to India and not to stay on in those places. That was the position some time ago. Later they modified it somewhat, but it is not quite clear what they are insisting on at the present moment. There is no question of anyone preventing them from returning; they are anxious that Indians should get out.

PANDIT S. S. N. TANKHA: I thought the Government of India had taken up the position that since they were living in other possessions of the Portuguese, there should have been no objection to their living in those areas, and further that they should not be compelled to return to India. I was enquiring if any reply hug been received from the Portuguese Government with regard to that matter.

SHRI JAWAHARLAL NEHRU: Yes, the Government of India se₀ no reason why these people who are carrying on lawful vocations there should be turned out.

CHINESE ROAD-BUILDING IN LADAKH AREA

- *26. SHRI N. SRI RAMA REDDY: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that the Chinese Communists ar_e operating ten-ton trucks on roads in Ladakh area; and

THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): (a) No, Sir, Government have no information that the Chinese are plying ten-ton trucks ir. the Ladakh area.
