THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) to (c) The draft programme of Urban Community Development was discussed by the Second Conference of State Ministers for Town and Country Planning held at Trivandrum in October, 1961, which recommended that the programme might be circulated for opinion amongst the State Governments. It was also recommended by the Conference that at least one pilot project may be undertaken in each State. The programme has accordingly been circulated amongst the State Governments. The Central Government intend to provide some financial assistance to the States; the pattern and other allied matters are under consideration. It is expected that a communication to State Governments in this regard will be issued; shortly.
