DAMAGE TO CROPS DUE TO LOCUSTS IN DELHI

- •152. SHRI S. C. DEB: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether any damage has been done to crop by the recent two successive invasions of locusts in Delhi and neighbouring areas;

(b) if so, to what extent?

THE DEPUTY MINISTER OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) and (fo) According to the information furnished by the Delhi Administration, the loss, which was mainly on *arhar*, mustard and pea crops, is estimated at Rs. 3 lakhs in an area of about 12 sq. miles. No information has so far been received in regard to the extent of loss in the neighbouring areas, namely, Punjab and U.P.

SHRI S. C. DEB: May I know, Sir, whether any effective measures have been taken so that damage to produce can be avoided?

SHRI A. M. THOMAS: About the 2nd of March 1962 there was this locust swarm and it had been effectively controlled by aerial as well as ground operations and most of the locusts in the swarms were killed.

SHRI N. SRI RAMA REDDY: May I know, Sir, if these locust swarms mostly came from West Pakistan?

SHRI A. M. THOMAS: That is so, Sir.

DR. R. B. GOUR: May I know, Sir, whether the hon. Minister and **the** Government have come into contact with the Zoological Survey of India which is doing certain research on the population dynamics of locust and whether those researches could be used by the Government in times of locust invasions?

SHRI A. M. THOMAS: We are prepared to receive any information that
