SHRI S. V. RAMASWAMY: The Criminal case arose out of a claim preferred by the East Khandesh Central Co-operative Bank, Ltd., Jaigaon as consignor and consignee of two consignments booked from Jalgaon to Indore and alleged to contain 'katha' and turmeric powder. They claimed Rs. 1 lakh odd for non-delivery and they filed subsequently suits in the civil court, which are pending. In this connection it was found that these claims were bogus claims. Thereupon a complaint was launched against ten persons.

SHRI DEOKINANDAN NARAYAN: Are any railway servants involved in this?

SHRI S. V. RAMASWAMY: Yes, Sir. Of the ten persons, five were railway employees.

SHRI N. SRI RAMA REDDY: May I know what happened to the civil suit filed?

SHRI S. V. RAMASWAMY: Apparently it is still pending.

SHRI AHMED MOHIUDDIN: It not correct to say that the unemployment that is there amongst a certain number of pilots is due to the standard of training. I repudiate that suggestion. The question of unemployed pilots has been considered, It was referred by the Speaker of the Lok Sabha to the Estimates Committee A report has been submitted and full information has been given. Secondly, a number of pilots have recently been employed, about nine have been taken by the I.A.F. They would not have taken the pilots from CATC if their training was of a low standard. number of pilots have also been employed by the I.A.C.

SHRI BIREN ROY: Has the ernment taken into consideration the discussions of the Estimates Committee and the proposal made by them that they should at least upgrade the standard of training, because this country has no instructors today and only 43 were trained at the CATC?

SHRI AHMED MOHIUDDIN: question of improving the standards higher and higher is always consideration. Of course, we some difficulties about employment of instructors and I hope they will also be overcome.
