sent a reply stating that they are agreeable to reduce the stamp duty. The State Governments of Uttar Pradesh, Punjab, Madhya Pradesh and Maharashtra are not agreeable to reduce the existing rates of stamp duty in their respective States. The matter is still under consideration of the other State Governments. The State Governments of Orissa and West Bengal are of the view that with effect from the 1st December, 1961, when Chapter III of the Advocates Act wa3 brought into force, the provisions of the Stamp Act relating to enrolment of a person as an advocate have become inoperative and no stamp duty is therefore payable for such enrolment after that date. The replies from other State Governments were received before 1st December, 1961, and this aspect was not perhaps considered by them.
