SHRI K. L. NARASIMHAM: Minister says that there was a guarrel between Gorakhpuri labour and the local labour. May I know, Sir, if it is not a fact that the workers' union there has been agitating against the Gorakhpur labour for the last several years in that particular area?

SHRI ABID ALI: Never agitating. One of the hon. Member's colleagues was on the Committee which appointed in this connection and a'ways maintained that Gorakhpuri workers should not be removed from this area and the'r relations were very happy. Now, Sir, this gentleman has been defeated in the last election, and we have received complaints that after the defeat of this Communist representative in this area. the Communists have become very aggressive and tension was there. To that extent complaints have been received.

SHRI K. L. NARASIMHAM: Sir, he is bringing irrelevant things here. He started with a quarrel at a toddy shop over a woman. Now he has drifted to elections. I should like to ask only one question. Is it not a fact that the Singareni Colliery Workers Union represented to the management that they should prevent Gorakhpuri labour from coming to this area anticipating trouble?

SHRI ABID ALI: No complaint to this effect has been received.

SHRI K. L. NARASIMHAM: May I know, Sir, if it is proposed to hold a public enquiry into the incident?

SHRI ABID ALI: A magisterial enquiry is taking place.

SHRI B. K. P. SINHA: May I know, Sir, if Government are aware that a very important Communist leader, Member of a particular State Assembly, demanded after these incidents that the Gorakhpuri labourers should be taken back to Gorakhpur, and may I know, Sir, if Government are prepared to concede this parochial demand of the Communists?

SHRI ABID ALI: No, Sir. There has been some demand recently. But, as I said earlier, this particular Member of the Communist Party was on the Comm ttee and he had different views. might have changed his views after his defeat in the election, but Government is not going to accept this suggestion.

## (Interruptions)

SHRI K. L. NARASIMHAM: Sir, he

MR. CHAIRMAN: He never brought the Party until you provoked h'm. Till then he was talking only about some natural sentiments.

SHRI ABID ALI: I have supplied him the information.

DISCUSSION ON KASHMIR ISSUE IN U.N.O.

\*217. Shri GURUDEV: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the Kashmir issue is to be discussed in

the United Nations Organisation in the near future; and

(b) if so, at whose instance the discussion is to take place and what is India's attitude thereto?

THE DEPUTY MINISTER OF EX-TERNAL AFFAIRS (SHRIMATI LAK-SHMI MENON): (a) and (b) Permanent Representative of Pakistan in the United Nations has made a request to the President of the Security Council for a meeting to consider the Kashmir situation. However, no date has been fixed for such a meeting yet.

Government feel that, as pointed out in our Permanent Representative's letter dated January 16, 1962, addressed to the President of the Security Council, this is a matter for a peaceful settlement by negotiation. As past experience has shown such debates cannot bring about a settlement.

## GOVERNMENT POLICY REGARDING PRICE-PAGE SCHEDULE

\*218. SHRI GURUDEV: Will the Minister of Information and Broad-CASTING be pleased to state what would be Government's future policy regarding the Price-Page Schedule for the newspapers published in the country consequent on the previous order having been quashed by the Supreme Court?

THE MINISTER OF INFORMATION AND BROADCASTING (Dr. B. V. KESKAR): In view of the Supreme Court's judgement declaring the Price-Page Schedule as invalid, it appears difficult to contemplate any further step in that direction.
