इन कारखानों की स्थापना करने के लिये काफी विदेशी मुद्रा सम्बन्धी जटिल समस्याये पैदा होने के कारण दोनों पार्टियों द्वारा जो उत्पादन को शुरू करने में समय लग रहा है, वह बहुत ग्रिधिक नहीं है।

इन कारखानों के पूरा न होने का परि-णाम अभो तक यह हुआ है कि देश में प्लास्टिक उद्योग के लिये कब्चे माल की कमी अभी जारी है।

The manufacture of P.V.C by M/s. Ahmedabad Manufacturing & Calico Printing Company Ltd, Ahmedabad is linked up with the manufacture of Calcium Carbide. Production of Calcium Carbide is reported to have already commenced and PVC, manufacture is expected to be completed by June this year.

The second plant for Polyethylene being set up by M/s Union Carbide India Limited, Calcutta includes manufacture of a number of organic chemicals apart from polyethylene This plant was inaugurated in March this year and some trial runs have commenced. Production is likely to be established in about two months time.

(b) Both the projects are complicated integrated schemes and owing to foreign exchange shortages it has been difficult to obtain supplies of capital equipment etc strictly on time. In case of the Polyethylene plant the land acquisition proceedings with the State Government also took slightly longer time than expected

In view of the complex issues involved in the setting up of these plants involving considerable foreign exchange requirements, the time being taken by both the parties to establish the manufacture of the items in question is not considered unduly long.

The result of the non-completion of these plants so far has been that the existing raw material shortages of the plastic industry in the country have continued]
