ed to any of these institutions for research work in this science?

Shri D. P. KARMARKAR: Yes, Sir, in the case of Uruli Kanchan for the year 1959-60 we gave a grant of Rs. 60,000—30 beds; for the Hyderabad institution we gave for 5 beds Rs. 10,000 and for the Lucknow one for 12 beds it was Rs. 24,000.

SHRI M. P. BHARGAVA: I am not concerned with such beds. I want to know whether any specific amount has been given for research work.

Shri D. P. KARMARKAR: Yes, Sir. I am concerned with those beds because they are the basis for research work.

"REGISTRY OF DISEASES"

- *86. Shri M. P. BHARGAVA: Will the Minister of Health be pleased to refer to the last paragraph on page 45 of his Ministry's report for the year 1960-61 and state:
- (a) where the office of the proposed "Registry of Diseases" to collect and integrate information on human pathologic material relating to diseases will be located; and
- (b) what will be the modus operandi for such registration?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) This will be decided after the scheme has been finalised.

(b) By selection of cases by histopathological diagnosis and by documentation of diseases by clinical and pathological analysis.

Shri M. P. BHARGAVA: May I know, Sir, why this mention in the report was made when the scheme has not yet been finalised?

Shri D. P. KARMARKAR: Sir, those things that are not finalised but are under contemplation are also mentioned.

Shri M. P. BHARGAVA: May I know by what time the scheme is likely to be finalised and what the modus operandi is going to be?

Shri D. P. KARMARKAR: I hope it will be finalised this year. The scheme will be worked under the auspices of the Indian Council of Medical Research, and the modus operandi will be the same as is normally followed in the case of such institutions.

MANJIRA WATER SUPPLY SCHEME

- *90. SHRIMATI SEETA YUDHVIR: Will the Minister of Health be pleased to state:
- (a) whether Government have approved the "Manjira Water Supply Scheme" in Andhra Pradesh for augmenting water supply to the cities of Hyderabad and Secunderabad;
- (b) if not, what are the reasons for the delay; and
- (c) what is the estimated cost of the scheme?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) Not yet.

- (b) Clarification on certain points had to be obtained from the State Government. The State Government's reply has been received. It is now hoped that the matter will be decided shortly.
 - (c) Rs. 3.75 crores.

SHRIMATI YASHODA REDDY. May I know, Sir, the main features of the scheme submitted by the State Government to the Ministry?

SHRI D P KARMARKAR Sir, the main features are as follows.

"The scheme envisages the provision of a barrage across Manjira river, pumping raw water from the lake to Pattamcheruvu village over a distance of 18 miles where it will be put through filters, a filtered supply of 18 mgd will be pumped again over a distance of 7 miles to a service reservoir on a ridge at Lingamapalli village, from where the supply will gravitate over a distance of about 12 to 15 miles to distribution system in the two cities"

I think that is sufficient for the time being

SHRIMATI YASHODA REDDY Will there be any further delay in its finalisation? How long will it take the Ministry to consider this scheme before accepting it?

Shri D P KARMARKAR So far as consideration is concerned, Sir, it is almost at the ultimate stage. I think, Sir, consideration will be finalised soon. How long it will take to complete it, will depend upon the monetary resources available and our capacity to utilise those resources early.

SHRIMATI YASHODA REDDY. Will it come in the Third Plan at least?

SHRI D P KARMARKAR: I am certain about it, Sir.
