श्री डी० पी० करमरकर : जी हां, देरी तो हो रही है लेकिन कुछ तो दूसरे कारण से हो रही है । हम,रा खत उनको गया है २९ अक्टूबर, १९६० को ग्रौर उसका जवाब आया है जनवरी १९६१ में ग्रौर इ.भने जो एसिस्टेन्ट डाइरेक्टर हैं वे वहा फरवरी में स्टडी करने के लिए गये हुए ये । झब कुछ ज्यादा देरी नहीं होगी ।

SHRIMATI YASHODA REDDY: May I know, Sir, the main features of the scheme submitted by the State Government to the Ministry?

SHRI D. P. KARMARKAR: Sir, the main features are as follows:

"The scheme envisages the provision of a barrage across Manjira river, pumping raw water from the lake to Pattamcheruvu village over a distance of 18 miles where it will be put through filters, a filtered supply of 18 m.g.d. will be pumped again over a distance of 7 miles to a service reservoir on a ridge at Lingamapalli village, from where the supply will gravitate over a distance of about 12 to 15 miles to distribution system in the two cities."

I think that is sufficient for the time being.

SHRIMATI YASHODA REDDY: Will there be any further delay in its finalisation? How long will it take the Ministry to consider this scheme before accepting it?

SHRI D. P. KARMARKAR: So far as consideration is concerned, Sir, it is almost at the ultimate stage. I think, Sir, consideration will be finalised soon. How long it will take to complete it, will depend upon the monetary resources available and our capacity to utilise those resources early.

SHRIMATI YASHODA REDDY: Will it come in the Third Plan at least?

SHRI D. P. KARMARKAR: I am certain about it, Sir.

## APPROVAL FOR POCHAMAPAD AND SRISAILAM PROJECTS

•91. SHRIMATI SEETA YUDHVIR: Will the Minister of IRRIGATION AND POWER be pleased to state:

(a) whether the Government of India have given their approval to the Government of Andhra Pradesh for the inclusion of the Pochampad Irrigation Project on Godavari river and the Srisailam Hydel Project on Krishna river in the Third Plan of the State; and

(b) if not the reason for which the approval has been withheld?

THE DEPUTY MINISTER OF IRRI. GATION AND POWER (SHRI J. S. L. HATHI): (a) and (b) A final decision on the projects to be included in the Third Plan of Andhra Pradesh has yet to be taken.

श्रीमती सीता युद्ध वोरः मंत्री महोदय को क्या यह पता है कि मंजुरी देने में देर करने से आन्ध्र प्रदेश की जनता में काफ्री नाराजगी इस बारे में है?

SHRI J. S. L. HATHI: The Andhra Pradesh Government are pressing for early sanction of this project.

SHRIMATI SEETA YUDHVIR: Will the Minister of IRRIGATION AND POWER be pleased to state the final outcome of the talks held by him with the Governments of Maharashtra, Mysore and Andhra Pradesh on the question of settlement of the dispute with regard to the distribution of the waters of the rivers Krishna and Godavari?

THE DEPUTY MINISTER OF IRRI-GATION AND POWER (SHRI J. S. L. HATHT): Discussions have since been held with the Governments of Maharashtra, Mysore and Andhra Pradesh and a decision regarding the further steps in the matter will be taken within the next few days.

SHRI J. S. L. HATHI: Really the discussions were held with regard to that very subject.

SHRIMATI YASHODA REDDY: Is it not a fact that the Pochampad project and even Nagarjunasagar itself were in a way based on the agreement reached earlier between the State Governments concerned and now if you revise the decision, it will cause difficulties?

SHRI J. S. L. HATHI: Nagarjunasagar is under execution already. But then the question has arisen between not three, but now, five States because Madhya Pradesh and Orissa also come in with regard to the distribution of the waters of the rivers Krishna and Godavari and therefore that matter is under examination.

SHRI FARIDUL HAQ ANSARI: May I know since how long this matter was under consideration or negotiation?

SHRI J. S. L. HATHI: The matter was taken up, I think, in September 1960 when the conference of the concerned States was held. The Minister of Irrigation and Power tried to bring about a settlement during the discussions but the States could not arrive at any settlement. Subsequently the Minister of Irrigation and Power went to each State and held independent consultations, negotiations and discussions with them, and ultimately we have come to a decision.
