SUBBARAYAN): (a) and (b) Detailed proposals in the light of the recommendations made by the Hotel Standards and Rate Structure Committee to regulate various aspects of the hotel industry including conditions of employment of hotel personnel are still being finalised. Since the problems of the hotel industry impinge upon the work of so many other Ministries of the Central Government, State Governments and the Travel Trade, the process of enacting an All-India legislation will inevitably take some time more.
