NEW RAILWAY LINES IN ANDHRA PRADESH
DURING THIRD PLAN

143. SHRIMATI SEETA YUDHVIR: Will the Minister of RAILWAYS be pleased to state what would be the total length and total cost of the new railway lines which it is proposed to take up during the Third Plan period in the State of Andhra Pradesh?

THE DEPUTY MINISTER OF RAILWAYS (SHRI S. V. RAMASWAMY): About 70 miles section of the Bailadil-la-Kottavalasa new line approved for construction during the Third Plan falls within the State of Andhra Pradesh. The entire project is estimated to cost approximately Rs. 55 crores.
