

- (ii) the requisite machines, instruments, tools and spare parts as well as the necessary training and teaching aids, c.i.f. port of entry, the total cost of equipment not exceeding 1,500,000 Swiss Francs.

B. The Council of Scientific and Industrial Research will provide—

- (i) an Indian Deputy Principal of the centre;
- (ii) Indian understudies to the Swiss instructors;
- (iii) necessary administrative and auxiliary personnel for the centre;
- (iv) suitable site, buildings and premises for the centre, the buildings being provided with adequate electrical and water installations, as well as an adequate number of telephones;
- (v) necessary equipment and furniture for the centre, in addition to the equipment supplied by the Foundation; and
- (vi) the other working expenses.

REFINANCING FACILITIES BY THE REFINANCE CORPORATION

•113. SHRI MAHESWAR NAIK: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that some new changes have been effected in the scheme of refinancing facilities offered by the Refinance Corporation for Industry Private Limited with the approval of the Government of India and the United States Technical Cooperation Mission in India;

(b) in what way the new changes are an improvement upon the scheme that existed before; and

(c) to what extent the volume of the business of the Corporation is expected to rise under the new scheme?

THE DEPUTY MINISTER OF FINANCE (SHRI B. R. BHAGAT) : (a) and (b) The scheme has been extended to cover more scheduled banks and certain other approved financial institutions. The maximum period of a loan has been increased from 7 to 10 years and the Corporation has been given a larger discretion to determine the eligibility of a particular industrial unit.

(c) With the liberalisation in the terms and conditions of refinance, the business of the Corporation has relatively increased in recent months.
