

(b) Absorption of "Pakistan Optees" in suitable posts and giving them the benefit of their previous service for purposes of pay fixation, pension, seniority, etc., was the entire responsibility of the Government of Pakistan. Such employees were given the benefit of fresh employment under the Government of India purely on compassionate grounds and the question of giving them any benefit for their previous service does not arise.
