- (e) The Commission have laid down the norms and standards for various types of buildings to be constructed by the colleges as guiding material and the colleges are advised to prepare their plans and estimates keeping these instructions in view.
- (f) No time-limit has been laid down by the University Grants Commission. However, under the conditions of allotment of lands, buildings are normally expected to be ready within two years of the allotment.

Financial assistance to the extent of 50 per cent. (75 per cent. in the case of hostels for girls) of the actual approved cost for all college buildings is given by the Commission.

- (a) whether any correspondence took place between his Ministry the Ministry of Information Broadcasting regarding the pay scales, duties and qualifications of the Sub-Editors of "Sainik Samachar" and the Assistant Editors of Grade III in the Central Information Service and if so, what are its details and what has been the outcome thereof; and
- (b) whether any information in regard to the pay scales and duties of the Translators of "Sainik Samachar" and Assistant Journalists in the Ministry of Information and Broadcasting has also been sought from the Ministry of Information and Broadcasting; if so, what has been the outcome thereof? 1

प्रतिरक्षा उपमंत्री (श्री के० रघरमेया) :

- (क) जी नहीं । तदापि, सूचना तथा प्रसारण मंत्रालय की केन्द्रीय सूचना सेवा के उप-सम्पादक, तथा तृतीय श्रेणी के सहायक सम्पादकों के वेतन दर, कर्त्तव्य, तथा श्रर्हताएं श्रनौपचारिक रूप से पता की गई थीं। इनके सविस्तार ग्रौर तुलनात्मक ग्रध्ययन से पता चलता है, कि सूचना तथा प्रसारण मंत्रालय के, तुतीय श्रेणी के, सहायक सम्पादकों के उत्तरदायित्व, सैनिक समाचार के उप-सम्पादकों से कहीं अधिक दुर्वह हैं।

DEPUTY †[THE MINISTER DEFENCE (SHRI K. RAGHURAMAIAH): (a) No, Sir. However, pay duties and qualifications of Sub-editors. and Assistant Editors Grade III Central Information Service in Information and Broadcasting Ministry have been informally ascertained. From a comparative study of details, it appears that the responsibilities of Assistant Editors Grade III in the Information and Broadcasting Ministry are more onerous than those of Sub-Editors in the "Sainik Samachar".

(b) A reference has been made to the Information and Broadcasting Ministry to inquire if the duties performed by Translators of the 'Sainik Samachar' can be compared with those of Assistant Journalists in that Ministry. This matter is under examination in that Ministry.]
