MR. DEPUTY CHAIRMAN: Which meeting?

Shri K. SANTHANAM: The meeting of the State Chief Ministers. This State Ministers' meeting, is it regular?

MR. DEPUTY CHAIRMAN: If the Government thinks it necessary, the statement may be laid. You may use . . .

Shri K. Santhanam: That is not a body recognized by the Constitution or by law or by a Resolution of the Government of India. It is an ad hoc meeting of Ministers and I do not see how it is proper to lay the statement issued by such a body before the Houses of Parliament.

Shri BHUPESH GUPTA (West Bengal): I think my hon friend's point is somewhat relevant, but in any case, since it has been laid on the Table of the House, may I suggest that there be a discussion on it also?

Shri K. SANTHANAM: I have no objection to the statement, a copy of which, perhaps, may be circulated, but I think it is irregular to place it before the Houses of Parliament, because it is purely an ad hoc body . . .

SHRI BHUPESH GUPTA: Another thing I wish to bring to your notice..

DIWAN CHAMAN LALL (Punjab): May I with your permission tell my learned friend that there is nothing in the Constitution or in the Rules of Business and Conduct of this House to prevent the Government from laying any document which the Government wishes to place on the Table of the House?

MR. DEPUTY CHAIRMAN: Thereis no point of order

Shri K. SANTHANAM: Are we also, any Member of the House, entitled to place any document considered important by us, on the Table of the House?

DIWAN CHAMAN LALL: Certainly, when my hon. friend or any Member of the House becomes a Member of the Government.

SHRI K. SANTHANAM: Is it privilege of the Government alone?

DIWAN CHAMAN LALL: Yes, it is so.

SHRI BHUPESH GUPTA: I understand the point raised by mv hon. friend. When it has been laid on the Table of the House, I shall get a copy of that statement, and when the hon. Member has raised it, the point should not be disposed of like this. Where is that rule? Which rule of the House says that the Government can lay on the Table of the House any paper unconnected with its normal functions? It is not so simple as that. I therefore would request you to look into it. I would like to have a copy of it and I also suggest a discussion on it.
