

(b) The U.K. Government have kept our High Commission in London informed about this matter.

SHRI P. C. MITRA: May I know, Sir, whether the Government of India have sent any communication to the United Kingdom Government giving a friendly caution against granting citizenship to an Indian who has fled India to avoid murders and from the clutches of law for committing cold-blooded murders and loot?

SHRIMATI LAKSHMI MENON: Sir, in the matter of U.K. citizenship, whenever anybody applies for their citizenship our High Commission in London is consulted and we give them the necessary advice.

SHRI N. SRI RAM REDDY: May I know, Sir, if Mr. Phizo will be repatriated to this country?

SHRIMATI LAKSHMI MENON: I do not know. If he wants repatriation, he will be repatriated.

SHRI MAHESWAR NAIK: May I know, Sir, what is the attitude of the Government of India in regard to the contention of Mr. Phizo that he is not an Indian citizen?

SHRIMATI LAKSHMI MENON: The contention of the Government is very clear, namely, that he is an Indian citizen because he belongs to Nagaland which is part of India.

SHRI N. KANUNGO: It was released for the actual user on the assurance of the State Government.

SHRI M. P. BHARGAVA: May I know, Sir, whether any complaints have been received from the State of Rajasthan about the misuse of camphor which is going on there?

SHRI N. KANUNGO: No, Sir.

MR. DEPUTY CHAIRMAN: Mr. Dahyabhai Patel has no question to ask on camphor. Questions are over.
