- (iii) Old wagons which had earlier been withdrawn from service have been pressed into service again by reconditioning them for short lead movements.
- (iv) A drive has been instituted to increase the originating wagon load by permitting loading to the extent of 2 tons in excess of the carrying capacity of a wagon.
- (v) In order to meet the shortfall, additional orders for the manufacture of 8500 CR and 'O' type wagons have been placed on the Railway Workshops against 1961-62 Rolling Stock Programme.
- (vi) Steps taken to *increase wagon output*
 - (a) Import of steel has been arranged by this Ministry in consultation with the Ministry of Steel, Mines and Fuel 'for items in short supply.
 - (b) As far as indigenous steel is concerned, the Ministry of Steel. Mines and Fuel have been kept advised periodi cally and a chasing organi sation set up in Calcutta.
